About the Mental Health Clustering Tool and Payment by Results

The MHCT has been developed in partnership between the Department of Health, the Royal College of Psychiatrists and the Care Pathways and Packages Project (CPPP) as a means of allocating clients to Care Clusters which in turn supports care planning and enables MH PbR. The MHCT retains HoNOS and thus supports providers and commissioners in measuring health and social care outcomes in mental health without the need to collect additional data.

HoNOS was published by the Royal College of Psychiatrists (RCPsych) in 1996 and is now the most widely used outcome measure in specialist mental health services in England and overseas.

The RCPsych has over 15 years experience of training clinical staff in the use of the HoNOS, working with staff teams to train them as trainers and with Trusts to develop and support Trust wide training and implementation plans.

The Royal College of Psychiatrists has developed, with the support of the Department of Health and CPPP, a diagnostic assessment to assist organisations in their planning and implementation of MHCT and MH PbR. This can be downloaded free of charge at www.rcpsych.ac.uk/cetc
