

Terms of submission to the British Journal of Psychiatry

These are the terms of submission of a manuscript (and, if applicable, any supplementary material submitted with the manuscript) to the British Journal of Psychiatry.

These terms are contractually binding. Should your manuscript be accepted by the British Journal of Psychiatry these terms will be incorporated into the Licence to Publish agreement you will be asked to sign prior to publication. These terms are intended to supplement those of the Licence to Publish agreement.

1. You warrant that you have read and agree to comply with the following guidance and guidelines and that any failure to comply with them shall represent a breach of these Terms of Submission:

You warrant that you understand and agree that, if the manuscript you are submitting passes an initial review for suitability, it will undergo peer review, according to the process set out at the Peer Review Policy Page and that the manuscript will be shared with parties involved in the peer review process.
