Steve is an emerging Anti-Racism consultant who works with senior leaders, helping them tackle racial inequality in their organisation, to deliver better outcomes for users of their service and staff alike.

Personal & familial experiences of racial discrimination are a significant driver for Steve's work. As a bi-racial child growing up in a largely white neighbourhood, Steve grew up not 'fitting in'. As he grew older Steve became aware of the role racial discrimination had in the high rates of serious mental illness on his father's side of the family. It was in learning to live with Bipolar Disorder that Steve started his work in Anti-Racism.
