## Introduction to the appendices

This is the appendices for your local report. Your local report is in a separate document. The appendices present data from Round 3 of the National Audit of Dementia, both at a national level and for your hospital. Data for your hospital in Round 2 is also shown where applicable. When comparing Round 2 data with Round 3 data, please be aware that differences in sample sizes and slight wording changes to some questions, can affect results in both rounds. Therefore, conclusions made from comparing the data should be with caution. Hospitals with less than five returns for the carer or staff questionnaires have not received any data and returns of 5 to 9 questionnaires have not received demographic information. The table below shows how the data tables in the appendices are laid out and what information you can find in each cell.

For the organisational checklist, data from 199 hospitals are included in the national audit column (all the registered participants).

195 hospitals participated in the casenote audit, returning 10047 casenotes and this is shown in the national audit column. The national audit column for the casenote audit also shows the median and the inter quartile range for each question (where applicable). Question items which were found to have lower agreement in the inter-rater reliability analysis (see audit [website](#)) have been coloured orange.

196 hospitals returned carer questionnaires. Data from all questionnaires (4664) is presented in the carer questionnaire data tables in Appendix E.

198 hospitals returned staff questionnaires. Data from all questionnaires (14416) is presented in Appendix G. For some questionnaire items, the data for the two most positive answers have been combined, as well as being presented separately. This is provided both at a national level and for your hospital.

At times, it is really difficult to maintain patients suffering from dementia privacy and dignity due to some behaviours associated with this illness. Staff try their very best but at times there are not enough of us and we are slower to respond than I would like. Discharging patients with dementia is complex and locally in the community, there are not enough facilities to meet individuals' needs so that they have prolonged hospital stays which exposes them to other risks.

## Registered Nurses (Band 7 or above)

Continuing to do the good work that they do, feel initial role of the dementia team has expanded so much that two things should happen: 1. Expansion on manpower of dementia team. 2. trust should recruit permanent mental health nurses on site to support high risk patients. They bring such a calming effect to our confused patients who are already in a strange environment. Their 1 to 1 presence helps not only support the wards and other patients, but ensure that dementia patients are treated with care and respect, that they are nutritionally supported and the pathway of hospital life for our patients is a seamless one.

Dementia friend volunteers to act as visitors for patients if families are not nearby.

Extra staff to sit and talk to patients.

Higher staffing level for 1:1 support where required and more leisure therapy for patients with dementia.

Improved staffing (though plans in place). Reduction in moving confused patients between wards.

The use of a day room would really help us care for patients with dementia; we could hold group activities and more lunch clubs.

To have access to temporary staff with specialist dementia training - this would enhance patient care, rather than just having a member of staff to watch them.

We need to encourage the involvement of friends and family and utilise tools for communication with this cohort.

## Healthcare Assistants

A communal lounge and TV.

Extra staffing for dementia patients to help spend more quality time with individual patients. Stimulation.

Have more staff and 1 to 1 with patients that suffer from dementia so they engage with activities if they are able too.

Have more training days in dementia.

I feel dementia link healthcare assistants should be employed on our ward to be able to give direct care for our dementia training. As a ward, we would benefit from being on a ground floor where we could have a garden. Finger food sometimes is late coming to the ward and is COLD. Need more thought to their age and patients not having teeth.

In the ward setting, we have dementia patients all sat up at the table with the visitors, enjoying meals together. This encourages patients to eat and socialise.

Increase staff so that we can give patients with dementia more time. The "this is me" completed in A&E/clinical decision unit (CDU) where possible.

More staff, so we can get to know the patients and be able to offer support.

More staff, staffing levels cannot cope with the level of dementia patients.

More trained staff to sit with the dementia patients.

Relevant number of staff on duty, to be able to give dementia patients the time they need.

St Augustine's ward is under staffed, this is challenging with people with dementia. "This is me" forms do not get filled in. Ward needs a day room and TV. Ward is not fit for dementia patients (approximately 3/4 of the ward is dementia).

## Doctors

Adequate training for doctor and nurses on management of dementia.

Government spending sufficient money on NHS, social services and health/ social care education (they have quite a catch up to do since 2010).

I think the regular training or eLearning on dementia would be a very good idea.

## Allied Healthcare Professionals

Coloured bays, clear signposts, more volunteers, music, TV.

Environmental factors such as colour contrasting, more nursing staff to support with more 1 to 1 care, reminiscence aids and more time to run groups.

For there to be day rooms on specific wards and a designated activity dementia worker to keep the dementia patients engaged and stimulated as they can often deteriorate during their hospital stay.

More volunteers to spend time with patients and more staff to special patients so they can safely walk around ward.

To provide dementia patients with more stimulation and entertainment at the bedside. Not all dementia patients are able to attend the dementia café or a day room, and staffing levels often don't allow for this anyway. So, I feel more needs to be done at the bedside. I feel that the dementia nurses should play more of a role in this. Currently I don't find that the dementia nurses are a support on the wards at all, and often just suggest that the electronic discharge note asks the GP to refer to the memory clinic.

Better training.

More training.

## Ward-based Administrators

Could have a specialised nurse on every ward that has had thorough dementia training.

I feel that patients with dementia should have more interactive activities based on the ward on a more regular basis to stimulate them. I feel that most patients with dementia sometimes become aggressive due to boredom.

Improved discharge could be beneficial to patients with dementia, currently delayed due to lack of external capacity to meeting the patients' needs in the community.

More activities for patients i.e. access to TV, music. More dementia lunches (currently 1 a week).  
Development of a ward garden for a safe place to sit and enjoy flowers/ sunshine/ bird life.

## Other / Unknown

More experienced staff with specialised training. More staff on the ward in general. More training and specialised equipment needs to be available.

More staff needed to work alongside people with dementia.
