**Event review.** It has been a fantastic year for the Occupational Psychiatry SIG. **Occupational Psychiatry Poster Prize.** Our trainee prize launched this year and ran at the summer meeting. Our 2024 trainee competition will run at our spring event and follow the same format of clinical scenario, based on an appropriately anonymised case or fictional presentation, with associated literature review and relevance for occupational impact and practice.
