

## ARCP Decision Aid: Core Psychiatry Training

Date: July 2022

The Core Psychiatry Training decision aid outlines the requirements for a satisfactory ARCP Outcome/completion of key progression point (outcomes 1 and 6).

This document can be used in conjunction with the main curriculum document and the trainee's Placement Specific Personal Development Plans (PDPs).

The Psychiatric Supervision and Educational Supervisor reports outline progression and recommended ARCP outcome.
